# Long Range Transportation Plan Progress and a Lesson Learned



INTERSTATE PLANNING COMMISSION TRIPLEW.ORG The Long Range Transportation Plan 2045 initiated by the Wood-Washington-Wirt Interstate Planning Commission in the Fall of 2020 is approximately 50% complete. To date a vision statement has been developed, Goals and Objectives defined, Advisory and Focus Group meetings have occurred, and numerous stakeholder interviews con-

ducted. During the most recent Advisory Group meeting preliminary project proposals were presented for discussion and further consideration. The next phase will be to continue to refine and prioritize projects based on needs identified through the modeling process, goals and objectives, performance measures and targets assessment, and fiscal constraint analysis. While there is still a significant amount of work to be done, we are well on the way of having a draft plan by July 31, 2021.



Public Involvement is an important component of the planning process. Under the direction of WWW, Burgess and NIple consultants has orchestrated an effective process despite the challenges created by the COVID-19 pandemic. To date all plan development efforts have been conducted virtually. This approach was first seen as a compromise to the traditional in -person meetings and public comment opportunities. However, it has proven to be a much more valuable tool than anticipated. While there is no substitute for person to person interaction, it seems that the virtual world provides some insulation for a person to be more open and freer to express thoughts and ideas. This has certainly been the case with this plan where we have seen increased participation from the public through interaction with online presentations and surveys. As we vaccinate ourselves out of the pandemic, there will undoubtably be some lasting effects that will not go away...virtual meetings...lesson learned!

# **Community Development Program Updates**

ARC awarded \$500,000 to the Mid-Ohio Valley Regional Council in Parkersburg, West Virginia, for the Building the Mid-Ohio Valley Recovery-to-Work Ecosystem Through Expanded Services and Support project. Organizations across the Mid-Ohio Valley of West Virginia and Ohio have come together to align program activities and provide an easily accessible roadmap for high-risk individuals to seek and retain employment. The program targets individuals who are making progress in their treatment plan or recovery and are nearing the point of workforce entry or reentry. The project will assist participants by expanding existing community linkage services, such as peer recovery supports, and making sure that those linkages extend across state borders. The project will expand successful recoveryfocused job training programs and provide education and incentives through employer outreach programs. Four workers/trainees will become Peer Recovery Supporters and 100 others will obtain employment during the project period. Additionally, 170 participants will benefit from legal and counselling services, and 26 businesses and 20 organizations will be improved.

The Wood County Development Authority was awarded \$40,000 for a Small Incubator/Coworking Space Feasibility Study from EDA. The deadline for proposals was April 1<sup>st</sup> and a consultant should be chosen in the near future.

The Elizabeth Wastewater Collection System Improvements Project has recently been completed by J.F. Allen Construction.

The Town of Cairo was awarded \$96,000 of IJDC Critical Needs grant funding for the Cairo Critical Needs Water Project. This work has recently been completed by Stonegate Construction.



Paden City Development Authority's board selected Civil Environmental Consultants to perform the Industrial Property Improvement Feasibility/Planning Study should they be selected for an EDA grant application MOVRC has submitted.

In addition, PCDA President Cork Bowen was just notified by EPA Region 3 contact Joe Nowak, that they have been chosen for the Technical Assistance grant that is administered through the WVDEP Remediation group in Wheeling. The Northern Brownfield Assistance Center helped PCDA with the EPA application.

The consulting firm ICF has been selected by DEP and has begun to build a scope of work for the project. Their mission is to provide a market analysis & research for Brownfield communities such as Paden City. The EDA Engineering Feasibility Study is a strong complement to the EPA project. ICF will be searching regionally & nationally to find potential tenants and the EDA grant can assist in identifying what new tenants will need and how much it will cost to make PCDA's properties ready.

The Tyler County Public Service District has received a letter of conditions regarding funding for the Centerville Alma Water Extension Project. The loan will be for \$2,019,000; the grant will provide \$965,000; and the Tyler County Commission will contribute \$507,600. The total project cost is estimated to be \$3,491,600. This project will provide public water to an additional 100 plus customers in the Centerville and Alma areas of Tyler County.
