WWW Considers Updates to

Essential Documents

The Wood-Washington-Wirt Interstate Planning Commission (WWW) is in the process of updating two documents essential in the transportation planning process. They include an update to the Transportation Improvement Program (TIP) for Fiscal Years 2021-2024, and an update to the Multi-Modal Long Range Transportation Plan.

The TIP is a document that is developed in coordination with federal, state, and local transportation partners to identify transportation investments that are programmed over a four year period. In addition to highway and transit improvement projects, that TIP incorporates multi-modal considerations such as bicycle and pedestrian improvement projects. The overall document is a comprehensive effort designed to respond to federal requirements to ensure the flow of federal transportation funds within the metropolitan area. Included in the document are specific components related to fiscal constraint, air quality conformity, performance measures, and environmental justice/Title VI. A draft document has been developed and is available for review on the WWW website athttp://www.triplew.org/. The WWW Policy Board will consider approval of the document during the May 20, 2020 quarterly meeting.

The Long Range Transportation Plan is a document that provides the foundation for transportation considerations and investment decisions document in the TIP. This document is required to maintain a twenty year planning period and include specific requirements that lead to the identification of transportation priorities over the planning period. The Plan is required to be updated every five years to reflect any changes in regional characteristics that may alter regional transportation project priorities. The Plan being developed covers the twenty year period through year 2045 and will be developed with a proactive public participation process to ensure the Plan is representative of local and regional transportation needs. The Plan development process in in the early stages with an anticipated plan completion date of December 2021. The planning process and progress made on the Plan will be documented and posted on the WWW website's

Updates from: FGP and SCP

Beginning April 1st, the hourly stipend rate increased for the volunteers from \$2.65 to \$3.00 an hour. The volunteers hadn't seen an increase for 18 years.

The Corporation for National and Community Service (CNCS) granted our volunteers a temporary pay allowance during this pandemic. The temporary pay is based on the volunteer's weekly average of the hours worked before the social distancing began.

Both FGP and SCP federal grants for 2020/2021 have been submitted and waiting approval.

During this pandemic, we all have had to think out of the box and find a new normalcy. The Foster Grandparent Program and the Senior Companion Program staff have continued to find new ways to connect with our senior volunteers and help with their isolation. One of the ways we have done this is through the collaboration with WV Extension with the Community Calling Program. The Program is a fun way to decrease isolation by pairing senior volunteers with WVU college students for two fun conversations via phone per week for 5 weeks.

FGP and SCP staff prepared packets for our volunteers with information on COVID-19, proper handwashing, a listing of all Senior Centers (Meal Sites) throughout the state, and resource guides, etc.

Real Property Improvement Tax Rebate Program

As the major population and employment center for 160,000 residents in the Mid-Ohio Valley, the City of Parkersburg is committed to providing area residents with the best quality of life. This includes access to employment opportunities and safe, affordable house. To catalyze new private investment in the community, Parkersburg City Council established a Real Property Improvement Tax Rebate Program (RPITRP) in December 2019, The Tax Rebate Program is designed to catalyze private investment and redevelopment in residential neighborhoods, industrial areas and commercial districts throughout the City of Parkersburg through new construction and/or rehabilitation projects.
