
Horizon 2045: Moving Toward a Brighter Future



Draft WWW LRTP Ready for Review!

The draft Horizon 2045 Long-Range Transportation Plan (LRTP) is now available for public review and comment. Horizon 2045 identifies recommended improvements to the transportation system in the Wood- Washington-Wirt Metropolitan Planning Organization (WWW) study area which includes Wood County, West Virginia and portions of Washington County, Ohio. The recommendations address transportation needs and deficiencies that were identified through extensive stakeholder and public engagement and technical analysis conducted by the project team. The website also includes an interactive map that provides details about the projects recommended in the draft LRTP. Print versions of the plan are also available for review at the WWW office located at **709 Market Street, Parkersburg, WV 26101**.



LRTP Recommendations

The draft Horizon 2045 LRTP considers all transportation modes and all users when recommending projects in order to create a robust and connected transportation network. The LRTP is required to be fiscally constrained, meaning the funding forecasted to be available to the MPO over the life of the plan will be sufficient to implement the plan's recommendations. However, some additional projects are included as "unfunded" to document priority needs that cannot currently be addressed in the fiscally constrained plan.

The financial plan was developed using revenue projections provided by the Ohio Department of Transportation (ODOT), West Virginia Department of Highways (WVDOH), and the Mid-Ohio Valley Transit Authority (MOVTA). Cost estimates were developed by the project team in coordination with the state DOTs. Current revenue projections estimate that approximately \$252 million will be available for transportation system improvements in the WWW region between 2022 and 2045. It should be noted that this amount only represents a portion of the total expected transportation funding because operations and maintenance typically accounts for a substantial portion of transportation spending but is not included in the LRTP recommendations.



Tell Us What You Think!

A public review period for the draft Horizon 2045 LRTP begins on August 18, 2021 and will run through September 19, 2021. There are several ways to comment on the draft plan. Following the public review period, WWC will prepare a final draft LRTP. WWC will provide the public with another opportunity to review the final draft plan in October before it is finalized and presented to the WWC Policy Board for approval.
